- 1. The Philippine Association of Practical Arts Supervisors, Inc., (PAPAS) and the Ministry of Education and Culture Region VI Vestern Visayas will jointly sponsor a Work-Conference of Practical Arts and Vocational Education Supervisors at the City Schools Division, Bacolod City on October 7-9, 1981.
- 2. The objectives of this PAPAS Work-Conference are to:
 - Review and reassess the productivity performance of practical arts supervisors on Work Ethics;
 - b. Share better ways and means of improving instructional, supervisory, and administrative strategies in the implementation of practical arts;

- d. Guidelines in unifying effectively the PARAS members.
- 4. The delegates to this work-conference are the regional, division vocational education supervisors in agricultural arts and industrial arts. Vocational supervisors of private and state colleges and universities are also authorized to attend this work-conference.
- 5. Participants will register in the afternoon of October 6, and a registration fee of two hundred fifty pesos (9250) per delegate shall be charged to cover conference expenses including handouts and kits. Per diems, travel allowance and board and lodging expenses for the duration of the conference will all be charged against their respective school/office fund, subject to the usual accounting and auditing regulations.
