SEMINAR-WORKSHOP ON THE SCHOOL HEALTH GUARDIAN PROGRAM

To: Bureau Directors
Regional Directors
Schools Superintendents

1. To gear the School Health Guardian Program to the goals and thrusts of the New Republic, a five-day seminar-workshop will be planned and conducted in each region by the chairmen of the regional and division working committees on health and nutrition.

- Expected to attend are the five members of the regional and division working committees as stated in MEC Memorandum No. 69, s. 1981. In addition, for the Mindanao regions, the World Food Program (WFP) regional and division coordinators who are not members of the Working committees as well as the chairmen of the WFP regional secretariat should attend the seminar-workshop; regional and division supply officers will attend during the first two days of the workshop. The number of participants allotted for each region is listed in Inclosure No. 1. In order that all regions can avail of the services of the consultants from the School Health and Nutrition Center, a suggested schedule of the seminar-workshop is also inclosed.
 - Representatives from the vocational schools/
 colleges health and nutrition working committees, and
 from the private school health officers associations,
 are encouraged to attend the seminar-workshop. The
 schools concerned are expected to shoulder the expenses
 of their respective delegates.
 - 4. The following are the objectives of the seminar-workshop:

- a. Orient the participants on the goals and thrusts of the New Republic, particularly those concerning health and nutrition and Paglingap I and II;
- b. Evaluate the projects of SHGP in the light of the above goals;
- Redirect plans for a more effective implementation, administration and supervision of the SHGP;
- d. Make plans for WFP Project expansion (Mindanao area) and phase-in/phase-out scheme of CARE, CRS; and
- e. Adopt ways and means to link nonformal education and SHGP.
- 5. The expected output of the seminar-workshop and the materials which the participants should bring to the workshop are given in Inclosure No. 2.
- 6. Travel expenses of the participants will be charged against the funds of the School Health and Nutrition Center, subject to the usual accounting and auditing rules and regulations.
- 7. It is desired that the contents of this Memorandum be brought immediately to the attention of all concerned and that a copy of the training design prepared by each region be submitted to this Office, at least a week before the scheduled date of the seminarworkshop, for the information and guidance of the consultants.
