1981 NATIONAL YCAP CONSULTATIVE CONFERENCE

1. Pursuant to the directive of His Excellency, President Ferdinand E. Marcos in his address during the 1981 Education Week held at Malacañang, Manila on September 9, a National YCAP Consultative Conference is scheduled on September 25-26 at the Development Academy of the Philippines in order to review the implementation of the Youth Civic Action Program.
2. Participants to this consultative conference who shall include sectoral and agency representatives of policy makers and field implementors of the Youth Civic Action Program are listed in the inclosure.
3. Expenses for the conference including transportation from MEC Arroceros to the venue and back, board and lodging and conference kits shall be chargeable against any MEC-YCAP or DAP-YCAP funds available, subject to the usual accounting and auditing rules and regulations.
