PHILIPPINE TUBERCULOSIS SOCIETY MATIONAL EDUCATIONAL AND FUND CAMPAIGN

To: Bureau Directors
Regional Directors
Schools Superintendents
Presidents, State Colleges and Universities
Heads of Private Schools, Colleges and Universities

- 1. President Ferdinand E. Marcos has issued Proclamation No. 2048 authorizing the Philippine Tuberculosis Society, Inc. to conduct a national educational and fund campaign from January 2 to December 31, 1981. The campaign aims at developing awareness of TB control measures and fostering the spirit of helping afflicted members of the community.
 - 2. It is requested that school officials, teachers and other school personnel give their support to the campaign and help the Society expand its services to more areas and to a bigger number of people to eliminate tuber-culosis as a major obstacle to the physical, social and economic well-being of our people. There shall be, however, absolutely no compulsion or any form of coercion upon school teachers and other personnel in the solicitation of the funds for the policy of this Ministry in fund campaigns, no matter how meritorious, is strictly voluntary.
 - In remitting collections, checks or money orders from school divisions, vocational schools and comprehensive high schools shall be drawn in favor of the Philippine Tuberculosis Society, Inc., and transmitted to the regional director's office which will in turn consolidate the remittances as these are received, indicating in summary report form the source of the remittances and the amount from the region. These will be transmitted to the Philippine Tuberculosis Society, Inc., Quezon Institute Compound, España

Extension, Quezon City. A copy of the summary report form shall be furnished this Office, Attention: Chief, Management and Audit Division, Financial and Management Service. Checks or money orders from the state colleges and universities shall be sent direct to the Philippine Tuberculosis Society, Inc.

- 4. Campaign fund receipts will be provided by the Philippine Tuberculosis Society, Inc. It may be mentioned here that donations or contributions given by private entities and by persons including public officials and employees shall constitute allowable deductions in full from the income of the donor for purposes of computing the maximum amount deductible under Section 30, paragraph (h) of the National Internal Revenue Code, as amended.
 - 5. Dissemination of this Memorandum to all concerned is requested.
