## 1982 PALARONG PAMBANSA

To: Eureau Directors
Regional Directors
Schools Superintendents
Presidents, State Colleges and Universities

- 1. The 1982 Palarong Pambansa will be held in Dipolog City on March 7-13.
- 2. The international rules and regulations implemented by the Philippine national sports associations, as modified by this Office to meet the needs of the Ministry of Education and Culture, shall govern the contests in the Meet.
- 3. The sports which shall be included in the 1982 Palarong Pambansa and the maximum number of players, coaches and chaperons of each regional delegation to the Meet are as follows:

273 - Overall members of the athletic delegation

4. Each delegation shall consist of not more than 273 persons, including head of delegation, athletic manager, delegation physician, delegation nurse, mess officer, finance and supply officer. For every player listed in two teams, the maximum number of members of the delegation shall be reduced by one. For example, athlete Carlito Santos appears in both the lists of baseball and track and field players. Although Santos will take part in two separate sports events, baseball and track and field (M), he shall be counted as only one member.

- 5. Entries in the Ralarong Pambansa shall be submitted to the Chairman, 1982 Palarong Pambansa, Dipolog City, in time for their inclusion in the official program, but not later than February 16, 1982.
- 6. The official colors of each regional athletic association as cited in paragraph 10 of the inclosure to Department Order No. 55, s. 1975 shall be strictly followed.
- 7. The head of each delegation shall be held responsible for the conduct and discipline of their athletes. Only athletes listed in the final entry as certified by the Chairman of the Screening Committee to have met all requirements on eligibility the day before the Meet starts will be allowed to play. This final list shall conform to the allowed number of athletes herein provided. No addition, substitution and alteration shall be allowed when the Meet has started.
- 8. Before departure for the Falarong Pambansa, every athlete should be given a thorough physical and medical examination to determine his/her fitness to undergo physical strain. An athlete found suffering from ailments as weak heart, defective lungs, or some communicable disease that will endanger the health of other people, should not be allowed to join the delegation. An athlete whose age is below 21 years shall have the written permission from his/her parents or guardian to participate in the athletic meet.
- 9. The chairman of each regional athletic association shall see to it that strict economy is observed. Expenses for uniforms should be at the barest minimum. Unnecessary expenses should be avoided.
- 10. The chairman of such regional association shall make arrangements for the transportation needs of their delegation to Dipolog City and return, payable from funds allotted for the purpose. Members of the delegation are entitled to third class transportation. Likewise, subsistence for the delegation shall be provided for the duration of the Leet, chargeable against the funds allotted therefor.
- Athletes and other members of athletic delegations, accredited 11. referees and umpires shall be provided quarters and beddings by the host division. School personnel designated as officials of the Meet who are not bonafide members of any delegation shall charge their transportation expenses to Dipolog City and back to Manila against the appropriation for the purpose from the MEC Sports Development Program Fund, MEC, Manila. Likewise, their ress shall be provided by the host. Schools superintendents/assistant superintendents who are assigned to officiate in the Meet shall charge their expenses against their respective travel permission with officials, achedl – allotments. Other their respective directors may attend the Meet, but their expenses shall be borne by their own local funds.

- 12. Each delegation shall take care of its own mess. Any delegation desiring to engage the services of local caterer at Dipolog City shall make the necessary arrangements as early as possible with the Chairman of the Palarong Pambansa. A delegation may be allowed twenty (20) kitchen personnel and muse, on official time only.
- 13. Heads of delegation, coaches, chaperons, physician, nurses, finance officers, athletic managers and mess supervisors shall mess with their delegation throughout the Meet.
- 14. A delegation member shall be allowed twenty-five (1/25) posss a day for subsistence. Maximum number of 33 meals for the duration of the Meet shall be allowed. Funds for the mess shall be released directly by the MEC to each of the thirteen (13) participating regions.
- 15. As a general rule, school personnel who have teaching assignments should not be assigned to accompany athletic delegations to the Meet, or act as Meet officials. If unavoidable, arrangements should be made so that teaching duties of such personnel are taken over by other teachers to avoid disruption of classes.
- 16. While officiating, male officials shall wear dark colored pants and white shirts or polo barong with long or short sleeves. Female officials will wear a white blouse over blue pants. Meet officials shall be provided with Palarong Pambansa headgear to be worn on duty.
- 17. The provisions of Department Orders Nos. 41 and 55, s. 1975; 53, s. 1976; 27, 48, 52 and 61, s. 1977, and MEC Orders Nos. 32, s. 1978; 55, 66 and 68, s. 1979; and 30, 44 and 45, s. 1980 shall prevail in all questions of eligibility of athletes and other matters concerning the Meet.
