MEC MEMORANDUM No. 56. s. 1982

1982 SPECIAL NCEE

To: Bureau Directors
Regional Directors
Schools Superintendents
Presidents, State Colleges and Universities
Heads of Private Schools, Colleges and Universities

- The Ministry of Education and Culture, through the National Educational Testing Center (NETC), will administer a special National College Entrance Examination (NCEE) on June 27, 1982, in Manila, Cebu City and Davao City from 8:00 a.m. to 12:00 o'clock noon. Regional directors of the National Capital Region and Regions VII and XI are authorized to register examinees and administer the special NCEE.
- The registration period will be from April 1 to May 31, 1982, at the offices of the regional directors concerned. Registrants should take along with them two copies of their latest photo, size 1" x 1" to be affixed to the Registration Form (NCEE Form I), and high school diploma or Form 138 (High School Card).
- The choice of venue for the examination is left to the sound discretion of the regional directors. The NETC will send its representative(s) to provide assistance in the administration of the test.
- 4. The following guidelines are hereby prescribed to determine those who are qualified to take the special NCEE:
  - a. Filipino citizens returning from abroad after the administration of the regular NCEE given on October 11, 1981. Filipino students current-ly enrolled abroad and who will be graduating

from the high school in May or June 1982, may be registered by their parents or guardians.

- b. High school graduates who took the 1978 NCEE but were not able to enrol in degree courses in college during the school year 1979-1980.
- c. Applicants who took the Philippine Educational Placement Test (PEPT) and on the basis of their test results were accredited as "having met the basic requirements for fourth year high school and therefore may be admitted to the next higher year level." They should present their original PEPT rating slips issued by the NETC.
- d. Those who registered for the October 11,1981 NCEE but were not able to take the test on said date due to illness as certified by a competent physician or a reputable hospital.
- 5. Foreign students from the ASEAN member nations desiring to enrol in Philippine colleges and universities shall take the NCEE administered in their respective Philippine embassies abroad. Residents of other foreign countries shall be served on request.
- 6. The registration fee per applicant is ten pesos (PlO.00). Applicants who fall under category 4-d above will likewise pay the registration fee. All fees collected from the applicants, together with the complete list of registrants, should be remitted to the National Educational Testing Center, MEC, Arroceros St., Manila, on or before June 15, 1982.
- 7. It is desired that the contents of this Memorandum be widely disseminated for the information and guidance of all concerned.
