d August 2-13, 1982 - Testing and interview of candidates by the MEC-UP teams in the venue chosen by the regional director for the NCEE orientation seminar

- e September 27, 1982 Final selection of scholars by the MEC-Philamlife-UP Scholarship Committee
- f October 4-23, 1982 Announcement of scholars, orientation and pre-enrolment activities
- g October 25, 1982 Registration in the university by the scholars
- Attention is invited to paragraph 4 of Department Memorandum No 138, s 1978, on Guidelines on the Continuing Program on Guidance Specifically, the paragraph stipulates among other things that candidates for the scholarship should be high school teachers and/or guidance counselors who are not over forty years old. They should have obtained an overall grade-point average of not less than 2 5 and without any failing grades in the undergraduate level.
- Attention is likewise invited to paragraph 5-c of the aforementioned Memorandum which enumerates the supporting documents that should accompany each nomination. Further, other scholarship requirements are specified in paragraphs 3 and 4 of MEC Memorandum No. 165, s. 1978
