YWCA PROJECTS IN BARANGAY ACCREDITED TO YCAP

To: Bureau Directors
Regional Directors
Schools Superintendents
Chiefs of Services and Heads of Units
Presidents, State Colleges and Universities
Heads of Private Schools, Colleges and Universities
Vocational School Superintendents/Administrators

1. The Young Women's Christian Association (YWCA) is a national and international youth welfare organization established in the Philippines in 1926. Its objectives, programs, projects, and activities are consistent with the redefined Youth Civic Action Program (YCAP) and specifically stress on the moral and spiritual value development of our youth.

2. Conformably with the directive of His Excellency, President Ferdinand E. Marcos to make the YCAP more meaningful and relevant as a national service program involving in-school youth in community development projects, the following YWCA projects, participated in by the youth in their respective school YCAP barangay laboratories under the close supervision of their respective school YCAP coordinators, are hereby accredited to the YCAP program:

- a. Educational Care and Reform (EDUCARE)
- b. Animal Care and Dispersal (ANICARE)
- c. Treeplanting Action Program (TAP)
- d. Value orientation and promotion of the spiritual and moral education
- e. National Volunteer Service in the barangay.

3. It is understood that the above-stated projects shall be credited to YCAP under the following conditions:

- a. That the school, college or university YCAP coordinator shall be oriented on the projects and be willing to serve as co-adviser of the YWCA chapter in their respective schools;
- b. That all YCAP-YWCA proposed activities shall be done in the approved YCAP barangay laboratory of each school;

- c. That proper coordination with the respective school YCAP Management Committee is done prior to actual conduct of YCAP-YWCA accredited activity;
 - d. That the counting of hours to be credited to YCAP shall correspond to the actual number of hours spent by the students in the YCAP-YWCA project under the close supervision of the school YCAP coordinator; and
 - e. That this accreditation shall be renewed annually by the School Provincial/City YCAP Management Committee or by the Regional YCAP Management Committee as the case may be, and in accordance with the YCAP accreditation requirements of the redefined YCAP.
4. The full cooperation of all concerned regarding this matter is hereby enjoined.
