**THE PHILIPPINE FOUNDATION FOR THE REHABILITATION OF THE DISABLED,
INC., MEMBERSHIP AND FUND CAMPAIGN**

To: Bureau Directors
Regional Directors
Chiefs of Services and Heads of Units
Schools Superintendents
Presidents, State Colleges and Universities
Heads of Private Schools, Colleges and Universities

1. Reproduced on the reverse side is Proclamation No. 2192 of the President of the Philippines authorizing the Philippine Foundation for the Rehabilitation of the Disabled (PFRD), Inc., to conduct a membership and fund campaign for a period of one year.
2. It is requested that school officials, teachers and other school personnel give their support to this campaign to help the PFRD to carry out its service programs for the over four million disabled persons (young and old) in our country. However, there shall be no compulsion or any form of coercion upon school teachers and other personnel in the solicitation of funds for the policy of this Ministry in fund campaigns, no matter how meritorious, is strictly voluntary.
3. Attention is invited to the manner of remitting collections. The check or money order from school divisions should be drawn in favor of the PFRD and transmitted to the Regional Director's Office, which, in turn will consolidate the remittances as these are received, indicating in summary form the source of the remittance (school division) and the amount. These will be transmitted to Deputy Minister Hermenegildo C. Dumlao, Chairman, Educational Institutions Division, Ministry of Education, Culture, and Sports, Manila.
4. Dissemination of this Memorandum to all concerned is **desired**.

PROCLAMATION NO. 2192

AUTHORIZING THE PHILIPPINE FOUNDATION FOR THE REHABILITATION
OF DISABLED, INC., TO CONDUCT A FUND CAMPAIGN DURING
THE PERIOD FROM MAY 1, 1982 TO APRIL 30, 1983

WHEREAS, the Philippine Foundation for the Rehabilitation of
Disabled, Inc., is a non-profit organization which provides assistance
to the disabled; and

WHEREAS, said organization needs public support to enable it
to carry on with its laudable objectives.

NOW, THEREFORE, I, FERDINAND E. MARCOS, President of the
Philippines, by virtue of the powers vested in me by law, do hereby
authorize the Philippine Foundation for the Rehabilitation of Disabled
Inc., to conduct a fund campaign during the period from May 1, 1982 to
April 30, 1983.

IN WITNESS WHEREOF, I have hereunto set my hand and caused
the seal of the Republic of the Philippines to be affixed.
