EIGHTH NATIONAL WORK-CONFERENCE OF PRACTICAL ARTS SUPERVISORS
AND VOCATIONAL EDUCATION SUPERVISORS

To: Bureau Directors
Regional Directors
Chiefs of Services and Heads of Units
Schools Superintendents
Vocational School Superintendents
Presidents, State Colleges and Universities

- 1. The Philippine Association of Practical Arts Supervisors, Inc. (PAPAS) and the Ministry of Education, Culture and Sports will jointly sponsor a work-conference of Practical Arts and Vocational Education Supervisors at the Marilao National Trade School, Marilao, Bulacan on October 11-13, 1982.
- 2. The objectives of the conference are:
 - a. to re-orient the participants on the practical arts program along the new elementary curriculum:
 - b. to gear the practical arts program to the KKK concept; and
 - c. to help finalize the guidelines in the implementation of KKK in schools.
- 3. At the end of the conference the participants are expected to:
 - a. gain deeper insight in the new elementary education curriculum;
 - b. articulate practical arts program with the KKK; and
 - c. produce a set of guidelines in the implementation of MECS KKK.

- 4. The delegates to this work-conference are regional and division vocational education supervisors (agricultural arts, industrial arts and fishery arts). Vocational supervisors of private schools, state colleges and universities and other national teacher training institutions are also authorized to attend this work-conference.
- Participants shall register in the afternoon of October 10, 1982. A registration fee of P300 per delegate shall be charged to cover conference expenses including handouts and kits. Per diems travel allowances, board and lodging expenses for the duration of the conference including registration fee will be charged against their respective school office fund, subject to the usual accounting and auditing regulations.
- 6. In this connection, attention is invited to paregraph 3 of MEC Order No. 17, s. 1982 requiring the submission by the sponsor of a post audit report of the collections and disbursements, which should be strictly complied with.
- 7. It is desired that the contents of this Memorandum be immediately brought to the attention of all concerned.
