FIRST NATIONAL CONFERENCE OF WOMEN EDUCATORS

- 1. The Philippines Field Chapter of Pi Lambda Theta, a National Honor and Professional Association for Women in Education, in collaboration with the Ministry of Education, Culture and Sports, and assisted by the Fund for Assistance to Private Education (FAPE), will hold the First National Conference of Women Educators at the University of Life on September 17, 1982.
- 2. The conference will finalize the recommendations/plans/
 programs that will promote women's participation in national development
 which were presented by the Regional Task Forces during the pre-national
 dialogue held on August 25, 1982 with the First Lady and Minister of
 Human Settlements, Madame Imelda Romualdez Marcos.
- 3. The conference will focus on two main concerns: (a) Professional Challenges to Women Educators; and (b) Leadership Challenges to Women Educators for Participation in Development.
- 4. The over-all objectives of the conference are:
 - a. to identify women leaders in education (both in formal system in all levels - elementary, secondary, tertiary and in non-formal educational settings) who are considered as recognized LEADERS of the profession in the various regions of the Philippines;
 - b. to provide a forum where women leaders in education may discuss the Association's two areas of concern:
 (1) Leadership in contributing professional expertise; and (2) Leadership in undertaking development participation; and

- c. to develop a concrete program of action for the Association within the context of regional situations towards strengthening the participation of women educators in the practice of the profession and enhancing their leadership contribution in the context of national development.
- 5. Regional position papers will be presented crystallizing the issues and problems that affect women educators in their desire to participate in leadership capacities, in the improvement of education and in the training of the youth for nation building.
- The following are authorized to attend the conference: deputy ministers, assistant secretaries, bureau directors, regional directors, service chiefs, executive directors, division chiefs in the general and regional offices, presidents of state colleges and universities, heads of private schools, colleges and universities, deans, schools superintendents, and representatives of CEAP, ACSC, PACU, PAASCU, and other associations, and educators in the private sector, who are women.
- 7. Fees and expenses for transportation, board and lodging, and other items that may be incurred in connection with attendance at the conference, shall be charged against local funds, subject to the usual accounting and auditing rules. Private schools and organizations may have their own arrangements regarding the expenses of their own delegates.
- 8. Attendance will be on official time.
- 9. Immediate dissemination of the contents of this Memorandum to all concerned is desired.
