RENDERING ASSISTANCE TO RESOLVE ISSUES AND PROBLEMS

To: Bureau Directors
Cultural Agency Directors
Regional Directors
Schools Superintendents
Presidents, State Colleges and Universities
Heads of Private Schools, Colleges and Universities
Vocational School Superintendents/Administrators

1. A copy of a Memorandum dated February 17, 1983 from the Office of the President is reproduced on the reverse side for compliance by all concerned.
2. The Memorandum is calling attention to the prevailing practice of sending people seeking help from different government ministries, bureaus and offices, to the Office of the President, for the solution of their problems.
3. This practice should be stopped. Action on appeal for assistance should be made at the office of first contact with the people. As much as possible, assistance to these people should be made without referring the matter to the President.

MEMORANDUM

TO : All Heads of Ministries, Bureaus, Offices, both National and Local and Government Corporations

Of late I have noticed that visitors from all parts of the country seeking help from the different government ministries, bureaus and offices are often told to go to the Office of the President because only the President can help them or solve their problems.

This practice of shunting off citizens to another office or "passing the buck" without any serious and sincere effort to help those who need assistance; or those who seek redress of grievances, or the recovery or protection of their rights, should immediately be stopped. Instead, action should be taken at the office of first contact with the people. At the same time, the agencies and offices that have anything to do with the issues raised, the problems presented, or the assistance sought should be contacted and requested or ordered to participate in the effort to resolve the issues and problems or to render the necessary assistance without referring the matter to the President.
