REGIONAL ECHO-TRAINING OF TRAINEES IN INTEGRATING
NUTRITION INTO AGRICULTURE CURRICULUM

To: Regional Directors
Presidents, State Colleges and Universities
Heads of Private Schools, Colleges and Universities
Vocational School Superintendents/Administrators

1. The University of the Philippines at Los Baños (UPLB), College, Legazpi in cooperation with the Ministry of Education, Culture and Sports, National Nutrition Council, and United Nations International Children's Emergency Fund will conduct a series of Regional Echo-Training Programs from June 6 to July 27, 1983 at the campuses of UPLB, CLSU, VISCA, and CMU with the following objectives:

- a. To adopt training modules for integrating nutrition into agricultural curriculum under the regional setting;
- b. To discuss the different methods of teaching the concepts of nutrition in agriculture and the learning experiences involved;
- c. To prepare the necessary teaching materials and other local tools of learning using local data and resources; and
- d. To draft a proposal for echo-training in their respective schools.

2. The above training is part of a national program of the National Nutrition Council aimed at enriching the technical capabilities of agriculturists in effectively contributing to the operational solution and nutrition problems at the grassroots level.

3. The tentative schedule of these training programs are as follows:

I, II and III	CLSU	June 20-29
IV, V and VI	WPLS	July 5-14
VII, VIII and IX	VISSA	July 18-27
X, XI and XII	CMI	June 6-15

4. Six agricultural colleges/universities will be involved in each region. Four participants from each school, particularly the instructors in Agriculture and Nutrition, who may be designated by their respective school heads are authorized to attend the regional echo-training on official time.

5. Transportation expenses to and from the venue of the training program and board and lodging of all participants shall be charged against the project funds, subject to the usual accounting and auditing regulations.

6. It is desired that this Memorandum be immediately disseminated for the information and guidance of all concerned.
