ACCREDITATION OF YADO ACTIVITIES

1. Quoted hereunder is the letter dated May 11, 1983 of the Honorable Deputy Minister Jose M. Crisol, Office of the Deputy Minister for Home Defense, Ministry of National Defense, to this Ministry, for the information and guidance of all concerned which is self-explanatory.

Dear Minister Corpuz:

My attention was called by some school authorities with reference to letters sent to various heads of educational institutions in Metro Manila by the Commanding Officer, Metropolitan Citizen Military Training Command, AFP last April 29, 1983. The letters have pertinence to the Youth Action Development Organization (YADO).

The MCETC letter emphasizes that activities of the YADO will not be credited as equivalent to, or substitute for Citizen Army Training I (CAT I) in secondary schools, or for Citizen Military Training (CMT) in colleges and universities.

We recognize the Youth Action Development Organization (YADO) as a special project under the Office of the President of the Philippines, as is embodied in MEC Order No. 50, s. 1979, published by your Ministry on August 1, 1979.

To avert any undue misunderstanding on the non-accreditation of purely YADO activities as equivalent to, or substitute for CAP I or CMC, we state herein that CNT for YADO members as officially conducted by the SCNTC or other AFP units in the Major Services authorized to conduct such training, will be duly credited for their CNT accomplishments.

These do not contravene with letter and spirit of MEC Order No. 50, s. 1979, dated August 1, 1979 (Reiterating the Accreditation of the Youth Action Development Organization (YADO)).

May we request widest dissemination of this information to the schools, colleges and universities concerned.
