FOURTH ANNUAL NATIONAL CONVENTION OF THE PHILOSOPHY
OF EDUCATION SOCIETY OF THE PHILIPPINES

To: Bureau Directors
Regional Directors
Schools Superintendents
Presidents, State Colleges and Universities
Heads of Private Schools, Colleges and Universities

1. The Philosophy of Education Society of the Philippines (PESP), in collaboration with the Ministry of Education, Culture and Sports and the Fund for Assistance to Private Education (FAPED) will hold its 4th annual convention at the Ateneo de Manila University, Loyola Heights, Quezon City on July 16-17, 1983.
2. Pursuant to national development goals, the theme of the convention is "The Social Dimensions of a Philosophy of Education." The objectives are:
 - a. to identify the social dimensions of a Philippine philosophy of education;
 - b. to articulate Philippine humanism and nationhood; and
 - c. to develop a social conscience and a sense of responsibility to one's neighbors.
3. On account of the timeliness and significance of the theme and objectives of the convention, particularly vis-a-vis the new thrusts of education, all heads of schools offering Philosophy of Education courses are enjoined to send the deans/professors/instructors concerned to the convention. The chiefs of higher education divisions in the MECS regional offices and educational researchers in the Bureau of Higher Education are authorized to attend.
4. Attendance is to be on official time. Registration fee is P250. Expenses incurred by the participants should be charged against local funds in the case of government

employees, subject to the usual accounting and auditing rules. Expenses of participants from private educational institutions shall be borne by their respective schools.

5. Immediate dissemination and implementation of the contents of this Memorandum is desired.


