CONSOLIDATED REPORTING OF ALL SCHOOL ACTIVITIES SUPPORTIVE  
OF THE KILUSANG KABUHAYAN AT KAUNLARAN (KKK)

To: Bureau Directors  
Regional Directors  
Presidents, State Colleges and Universities  
Schools Superintendents  
Vocational School Administrators

1. In order to obtain a more comprehensive data on this Ministry's Program in support of the Kilusang Kabuhayan at Kaunlaran and in line with the objectives stated in MECS Order No. 1, s. 1983, reports on all school livelihood and related activities shall be made in the inclosed MECS-KKK Form I, and submitted to the MECS-KKK Project Management Secretariat, Arroceros, Manila. Said reports shall be made at the end of every semester to reach this office not later than November 15, for the first semester and March 15 for the 2nd semester.

2. In addition to the projects which were started under the MECS-KKK Program, reports in connection with the following MECS issuances shall be made in the inclosed Form I, to wit:

- a. Department Memorandum No. 94, s. 1975 - Project Alay Parik
- b. Department Memorandum No. 22, s. 1975 - Letter of Instructions No. 248 Ret "Guilayan Da Kalusugan"
- c. Department Order No. 29, s. 1977 - DEC Tree Planting Action Program (TAP): Implementing Guidelines
- d. Department Memorandum No. 124, s. 1977 - Establishment of School Orchards
- e. SEC Memorandum No. 310, s. 1978 - Promoting Small- and Medium-Scale Home Industries Through In- and Out-of-School Projects/Activities







- f. MEC Order No. 25, s. 1980 - Directing the Acceleration of Manufacturing Operations of National Schools (To implement LOI No. 1026; 872; 526)
- g. And other MECS livelihood programs in cooperation and/or covered with Memorandum of Agreements with other government agencies and/or instrumentalities e.g. CE-MECS; MECS-RAJ; MECS-NAR; etc.

3. In order to further maximize the participation of this Ministry in support of the program, teachers and other personnel who possess technical training and know-how are expected to help in the training of prospective and/or actual beneficiaries of the KKK. For better planning and coordination, a national roster of technical manpower is needed. In view of this it is also requested that the enclosed MECS-KKK Form 2 be accomplished and immediately submitted to this Office.

4. All other issuances on livelihood that are not included in this Memorandum are hereby rescinded.

5. The serious attention and consideration of all concerned is requested.
