NINTH NATIONAL CONGRESS OF COLLEGE STUDENTS AND FOURTH  
NATIONAL CAMPUS ADVISERS SEMINAR

To: Bureau Directors  
Regional Directors  
Schools Superintendents  
Presidents, State Colleges and Universities  
Heads of Private Schools, Colleges and Universities

1. In line with the government's emphasis on youth involvement in nation-building, the Manila YMCA, with the cooperation of the Ministry of Education, Culture and Sports, will hold the Ninth National Congress of College Students and Fourth National Campus Advisers Seminar at the Senior High, Teachers Camp, Baguio City on December 18-22, 1983.

2. The theme of the congress is "Building Tomorrow's Leaders" and for the advisers seminar, "The Mathetic of Service" with the following sub-topics:

For the Congress:

- a. Youth Leadership and the Family
- b. Youth Leadership and the School
- c. Youth Leadership and the Church and Other Institutions

For the Campus Advisers:

- a. Establishing Program Strategies and Directions
- b. The Value of Shared Leadership

3. The congress intends to attain the following objectives:

- a. To make the youth understand the growth and development of leaders
- b. To re-study the institutions influential in the acquisition and nurture of leadership qualities, skills, potentials and attitudes
- c. To imbue youth leaders with the theoretical framework of a worthwhile activity for regional and national development.







4. The congress is open to college students taking degree courses, preferably those with experience in youth leadership training projects/activities. A student-delegate should be at least a second year college student and should be recommended by a school, college or university head. The advisers seminar is open to faculty members involved in campus organization projects/activities.

5. All schools, colleges and universities are urged to participate in the Congress. Heads of schools, colleges and universities are authorized to recommend not more than ten (10) selected students from each institution to attend the Congress and not more than two (2) for the Advisers Seminar. Deadline for the submission of applications of student-delegates and for advisers is November 16 for provincial delegates and November 26 for Metro Manila delegates. Inclosed are copies of the application forms for the Congress and for the advisers seminar.

6. Congress and advisers fees of P360 which covers accommodations, transportation for Manila-Baguio-Manila, meals, insurance, materials, certificate, and other expenses that may be incurred in connection with attendance thereto shall be borne by the school, college, or university represented therein or by any private organization. In this connection, attention is invited to Paragraph 3 of NECS Order No. 17, s. 1982 requiring the submission by the sponsor of a post-audit report of the collections and disbursements which should be strictly complied with.

7. A certificate of attendance signed by the Chairman of the College Work Committee, the President, Executive Secretary of the YMCA of Manila, and the Executive of the Congress will be given to each participant.

8. Student-delegates and advisers shall submit reports on their participation in the Congress and Advisers Seminar, respectively, which shall include a summary of the discussions taken up, prescribed materials and handouts, as well as their recommendations.
