LANGUAGE EDUCATION COUNCIL OF THE PHILIPPINES
SCHOLARSHIP GRANT

To: Bureau Directors
Regional Directors
School Superintendents
Presidents, State Colleges and Universities

1. The Language Education Council of the Philippines (LEDCO) is launching a five-year integrated scholarship in Bilingual Education, major in TESL/Filipino beginning the Second Semester, SY 1983-84.
2. The aim of the scholarship program is to present an alternative scheme for upgrading the competencies of language educators in remote schools and regions throughout the country who will assume the leadership in the region and to provide a more comprehensive reorientation and training than the usual seminar-workshop being offered to teachers.
3. The University of the Philippines, Philippine Normal College, De La Salle University and Ateneo de Manila University are the participating institutions in the training program.
4. There will be forty (40), one semester graduate scholarship grants leading to a LEDCO Certificate of Proficiency in Bilingual Education.
5. The scholarship grant will consist of a monthly stipend of P700.00, free tuition and book allowance, and transportation fare to and from Manila and the provincial station of the grantee. The counterpart fund will be the grantee's monthly salary during the period of scholarship which will be paid by his school and to be certified by the head of the institution. If this is not possible, a statement of waiver signed by the grantee indicating his willingness to accept the scholarship even without payment of his salary should be presented to LEDCO.

6. Each candidate should present the following:
- transcript of records,
 - medical certificate,
 - recommendation and certification of the head of the school that the candidate is the regular faculty and that counterpart funds in monthly salary during the scholarship will be paid to the grantee or a statement of waiver of the salary signed by the candidate, and
 - letters of reference of the chairman and/or former professor of English of the nominee certifying that he has the capacity to pursue graduate work.
