1984-85 NSTA-SPI-PNC SCHOLARSHIP PROGRAM

To: Bureau Directors

Heads of Private Schools, Colleges and Universities

1. The National Science Technology Authority (NSTA) will award forty (40) scholarships at the Philippine Normal College to those who will pursue any of the following courses of study: BS Physics for Teachers and BS Mathematics for Teachers. The aim of the scholarship is to produce high quality physics and mathematics teachers for secondary public and private schools.
2. Pertinent information regarding the qualifications of applicants, scholarship privileges, scholarship requirements and necessary documents to be submitted are inclosed. All items to be submitted by applicants must be received not later than December 12, 1983 in any of the NSTA Field Offices listed in the inclosure.
3. This Office entitles the assistance and support of the regional directors to encourage wide participation of the most deserving and qualified students to take the examinations on January 15, 1984 at the test centers found in their region.
4. Immediate and wide publicity of this Memorandum is desired.

Announcement for the 1984-85 NSTA-SPI-PNC

DSTI/SEPT Scholarships

I. General Information

A. Scholarships

The National Science and Technology Authority shall award forty (40) scholarships to those who elect to pursue any of the following courses of study:

20 BS Physics for Teachers

20 BS Mathematics for Teachers

B. Qualifications of an Applicant

1. Must be qualified for graduation from any public or authorized private high school in March 1984;
2. Must be classified within the upper 15% of the graduating class;
3. Must be a natural-born citizen of the Philippines and a resident of the region he is representing;
4. Must be in good health and of good moral character;
5. Must be willing to return to his region to teach physics/mathematics in the secondary school.

Note: Those who have applied for the NSTA-SPI-Undergraduate Scholarship should not apply for this scholarship.

C. Scholarship privileges per academic year

1. Actual tuition and other school fees as billed by the Philippine Normal College and/or De La Salle University;
2. Outright grant for prescribed textbooks and essential school supplies first and second years at ₱300/yr. and subsequent years at ₱600/yr.;
3. Outright grant for prescribed Military Science and Physical Education uniforms of ₱240/yr. during the first two years;
4. Free transportation for one economy-class round trip between the permanent residence and the Philippine Normal College;
5. Monthly living allowance for ten-month duration of ₱600.

Additional allowance during summer of the third year

1. Allowance for seven weeks

2. Actual purchase of books and essential school supplies not to exceed ₱100

3. Free transportation for one economy-class round trip between permanent residence and the Science Teaching Center assigned.

2. An awardee must maintain a weighted average of 83 or better;
3. Immediately upon completion of his bachelor's degree, an awardee shall serve as a full time mathematics/physics teacher in a secondary school in his own region for a minimum period equivalent to the length of time he enjoyed this scholarship;
4. An awardee shall comply with the terms of a scholarship agreement to be entered into between himself, his parent/guardian and NSTA-PNC.

B. Items to be submitted:

1. NSTA-SPI-PNC Information Sheet, using attached Form A
2. Certification from the high school principal on the following: (using attached Form D)
  - a. qualification for graduation in March 1984;
  - b. the applicant belong to the upper 15% of the graduating class;
  - c. total number of candidates for graduation.
3. Health certification from a qualified physician (using attached Form D)
4. Certification on good moral character from the Guidance Counselor/Principal (using attached Form C)
5. Two 1" by 1" pictures taken recently, one to be attached to the NSTA-SPI-PNC information sheet and the other to the notice of admission
6. Certification by the applicant of his willingness to teach high school physics and mathematics after graduation in the region of residence (using Form E)

The aforesaid items required of the applicants should be submitted by every school at one time to the NSTA Field Office in their respective regions. Only applications of those who will take the scholarship examination in Metro Manila should be sent to the Philippine Normal College, Manila.

The notice of admission will be sent immediately to the sending school distribution to its applicants. In case the notice is not received before the examination day, the examinees may proceed to their respective testing centers and check with the NSTA Field Office the day before the examination.

2. The examinee shall defray from personal funds his subsistence and transportation expenses to and from the examination center.

3. The examination shall include Aptitude Tests in Science (Biology, Chemistry, Integrated Science and Physics), Mathematics, Arithmetic, Algebra, Geometry and Trigonometry) and Communication Arts.

D. The awardees shall be selected on the bases of their performance on

1. 1984 NSTA-SPI Scholarship Examination

2. National College Entrance Examination

C. Forty scholarship slots (20 for physics and 20 for mathematics) shall be awarded to the qualified candidates from the 13 regions of the country who got the highest scores in their respective regions provided that such scores fall within the prescribed minimum acceptable scores.

Selection of qualified examinees for the scholarship award after approval of the NSTA Director General is final and unappealable.
