SCHOLARSHIP SELECTION TEST FOR PHYSICALLY-HANDICAPPED STUDENTS

To: Bureau Directors
Regional Directors
School Superintendents
President, State Colleges and Universities
Vocational Schools Superintendents/Administrators
Principals of Special Schools

1. The selection test for the mentally gifted but physically-handicapped high school students graduating from special schools or any public, private or vocational secondary school this current school year will be administered by the National Scholarship Center, this Ministry, on March 15, 1984.
2. An applicant to this test shall possess the following qualifications:
 - a. He is physically handicapped: blind, deaf, or an orthopedic case of permanent nature;
 - b. He is among the top five of the high school graduating class; and
 - c. The joint annual gross income of his parents or court-appointed guardian does not exceed ₱2,000.00 as evidenced by the parents' BIR Income Tax Return as of CY 1982.
3. An applicant's qualifications as stipulated above shall be supported with authentic documents.
4. A local screening committee composed of the following shall be created to evaluate and nominate qualified candidates based on the aforementioned criteria:

Member Advisor of Fourth Year Class
Member School Guidance Councilor

Chairman Principal of the Special School

Member School Guidance Councilor

5. The venue of the test for applicants in Metro Manila will be the Philippine School for the Blind in Pasay City; for applicants outside of Metro Manila test sites will be determined by the schools superintendents concerned.

6. Those who will qualify in the test shall be awarded a state scholarship effective school year 1984-1985.

7. Deadline for the submission of the list of qualified applicants (using MEC included form) to the National Scholarship Center, Ministry of Education, Culture and Sports, Arroceros Street, Manila is March 5, 1984.

8. Immediate dissemination of this Memorandum to special schools and other schools concerned is desired.
