REGIONAL NFE IMPLEMENTORS' TRAINING ON KILUSANG SARILING SIKAP
SELF-RELIANT HOME MOVEMENT PROGRAM

To: Bureau Directors
Regional Directors
Schools Superintendents
Presidents, State Colleges and Universities

1. In line with the nationwide launching of the Kilusang Sariling Sikap (KSS) as stipulated in Letter of Instructions No. 1362, the Bureau of Continuing Education (BCE) of this Ministry will conduct in NFE regional centers all over the country a series of five-day Regional Implementors' Training Sessions for the effective implementation of the KSS Self-Reliant Home Movement Program through the non-formal education network. The first and second sessions of this activity will be piloted in Regions III and VI on May 24-25 and June 4-6, 1984, respectively. The schedule for other regions will be announced later in a separate Memorandum.
2. This training workshop is aimed at gearing the Nonformal Education Program towards the furtherance of the Kilusang Sariling Sikap including the development of work ethic, thrift and citizenship skills and dissemination of Filipino ideology and to enable the out-of-school youths and adults including other target clientele to acquire basic life-long learning technologies for family home development.
3. Participants will be composed of assistant superintendents in charge of nonformal education for every division in the region, one NFE regional supervisor, one vocational regional supervisor, one division NFE and one practical arts supervisor from the nearest division, two district NFE coordinators from the nearest districts, six barangay leaders plus two XB chairman from the nearest barangays, one representative each from the Ministry of Human Settlements, Ministry of Local Government and Community Development, Ministry of Social Services and Development, Ministry of Health, Bureau of Agricultural Extension, Bureau of Animal Industry and National Youth Manpower Council.

4. It is expected that at the end of the five-day training, the participants shall have developed an integrated action plan focusing on the NCC Program areas of concern and NCS 7 areas of the self-reliant home movement to be implemented, monitored and evaluated regularly. At least one community should be chosen as a model in each division.

5. The program of activities are inclosed with this Memorandum. For purposes of setting up the training venues, dates and other important details, regional directors are earnestly requested to coordinate with the Bureau of Continuing Education, MFGS, Intramuros, to facilitate the smooth conduct of the training program.

6. Board and lodging will be provided at the training venue from the Bureau of Continuing Education (BCE) funds. Transportation expenses of the participants may be charged against local funds, subject to the usual accounting and auditing requirements.

7. It is desired that wide immediate dissemination of this Memorandum be brought to the attention of all concerned.
