SUMMER PROGRAM ON STAFF DEVELOPMENT UNDER THE TECHNICAL AND VOCATIONAL EDUCATION PROJECT ADB LOAN MANAGEMENT 531-PHI

To: Bureau Directors  
Regional Directors  
Presidents, State Colleges and Universities  
Vocational School Superintendents/Administrators

1. Pursuant to Schedule 6 paragraph 7 of ADB-LA No. 531-PHI, the Management of the Technical and Vocational Education Project under the Ministry of Education, Culture and Sports is conducting training programs to upgrade the technical and academic competencies of selected teachers who will teach the MFT program to be implemented this school year 1984-1985 as well as the non-teaching personnel in relation to their roles, functions, and responsibilities in the implementation of the technical and vocational education program. These training programs shall be held at the National Center for Technical Education and Staff Development (NCTESD), Marikina Institute of Science and Technology, Marikina, Metro Manila; Regional Center for Technical Education and Staff Development (RCTESD-Luzon) at the Manila Technician Institute (VTI), Taguig, Metro Manila; and (RCTESD-Visayas) at the Cebu State College of Science and Technology (CSCST), Cebu City as follows:

- a. 1984 Summer Teacher Upgrading Course in Mathematics, Chemistry and Physics at the MIST; April 30 to June 8, 1984 with partial financial support from the Pilipinas Shell Foundation, Inc. (PSFI) under special scholarship training tie-up with the TVEP.
- b. 1984 Summer Teacher Upgrading Course in the Seven Technology Areas (Automotive, Electrical, Electronics, Machine Shop, Refrigeration and Air-Conditioning (RAAC), Welding and Fabrication, and Civil) at the Manila Technician Institute in consortium with MIST as the accrediting/degree-granting institution - April 30 to June 8, 1984.
- c. Training of Teachers in the Use of Instructional Materials in Work Ethics and Social Science at MIST - April 30 to May 12, 1984.
- d. Training of Teachers in the Use of Instructional Materials in Technical Drawing and Physical Education at the MIST, May 16-19, 1984.







e. Integrated Curriculum Development and Teacher Training in English for Special Purposes at the MEST - May 21-28, 1984 with a British Council Consultant providing technical assistance.

f. Training of Non-teaching Personnel in Technical and Vocational Education Project Implementation at (RCTESD-Visayas) CSCET, May 21-June 1, 1984.

2. Participants/Consultants shall be selected from private industries/consulting firms/other agencies, and project institutes.

3. Travel expenses incurred to and from the school in connection with these activities shall be charged against recurrent cost of the TEI, while food and accommodation and supplies and materials shall be charged against TVEP funds.

4. Immediate dissemination of the content of this Memorandum to all concerned is hereby enjoined.
