2-DAY CONSULTATIVE CONFERENCE IN POPULATION EDUCATION

To: Regional Directors

1. The Population Education Program Unit of the Ministry will hold a 2-day consultative conference on December 13-14, 1984 at the Dr. A. Albert Elementary School, corner Casañas and Kapitán Ste., Sampaloc, Manila.
2. Viewed as a consultative forum, the conference will address the following objectives:
 - a. Discuss the status of UNFPA assistance to the regional population education programs;
 - b. Discuss recommendations on the institutionalization of population education drawn from the interim evaluation study of the Second Country Project;
 - c. Describe PEP efforts and future plans for the institutionalization of population education in the MECS ongoing processes;
 - d. Prepare plans for the institutionalization of population education in the MECSROs.
3. Participants to this conference are the Regional Director, PEP Executive Officer and Regional PEP Coordinator from each region, and PEP Central Office staff.
4. Travel and other expenses incident to attendance in this conference shall be charged against MECS-PEP UNFPA Funds, subject to the usual accounting and auditing regulations.
