1984 SCHOOL HEALTH GUARDIAN PROGRAM CONTEST

To: Bureau Directors
Regional Directors
Schools Superintendents
Presidents, State Colleges and Universities
Heads of Private Schools, Colleges and Universities
Vocational School Superintendents/Administrators

1. In compliance with the objective of LOI No. 764 of enriching the health education and services program of the Ministry, the 1984 SHGP contest shall be held this year as it has been during the previous years.
2. Of the four division entries under the Alay Tanim contest, one division will be evaluated as an SHGP entry during the national evaluation for the purpose of the 1984 SHGP contest.
3. School divisions that have won for three times on the national level and divisions that have won five times on the regional level shall not be included in the national evaluation but will be given an Award every year thereafter, provided the projects will be maintained and improved.
4. There will be four winners: one each for Luzon, Southern Tagalog and Bicol, Visayas and Mindanao. The National Committee on Evaluation will announce the winners in December 1984, whose decision will be final.
5. Inclosed are the criteria for the selection of national and regional winners.
