SEMINAR-WORKSHOP ON THE FINALIZATION OF MECS PLAN
FOR CY 1985 AND PROPOSALS FOR CY 1986

1. A two-day seminar-workshop to finalize, MECS Plans and Projects for 1985 and 1986 will be held at the Teachers' Camp, Baguio City on January 20-25, 1985. The Office of the Planning Service is coordinating this activity with funding from PRODED.

2. The specific objectives are as follows:

- a. To review MECS programs and projects implemented in 1984; to determine what projects will be implemented in 1985; and proposed projects for 1986.
- b. To prioritize programs and projects and specify yearly targets, with due consideration to the directions indicated in the 1984-1987 MECA plan, the thrusts of each of the major delivery programs, and the continuing goals and objectives of the major educational delivery programs.
- c. To organize projects by delivery program and by agency to facilitate evaluation of programs and agency performance.
