REDUCTION OF PRICES OF GOVERNMENT PURCHASES  
THRU THE SUPPLY OPEN END ORDER SYSTEM

To: Bureau Directors  
Regional Directors  
Presidents, State Colleges and Universities  
Vocational School Superintendents/Administrators

1. Issued as an inclosure to this Memorandum is General Services Administration Circular No. 1 dated May 8, 1965 which is self-explanatory. Pursuant thereto, all regional and division offices, presidents of state colleges and universities, and vocational school administrators/superintendents under this Ministry who purchase their government supplies through the Supply Open End Order System (SOO) are hereby directed to negotiate further with accredited government suppliers holding valid SOO contracts to lower their prices previously set in view of the reduction in the prices of gasoline, oil products and other prime commodities.

The General Services Administration through the Supply Coordination Office is currently conducting a review of the ceiling prices of items covered by the Supply Open-End Order (SOO) contracts in view of the reduction in the prices of gasoline and other oil products, electricity, transportation and other prime commodities.

Pending the results of the review, all ministries/agencies and other government instrumentalities concerned are hereby requested to negotiate further with accredited government suppliers holding valid SOO contracts for the lowering of prices previously set by this office.
