MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS;

This AGREEMENT entered into at Pasig, Metro Manila this 13th day of November 1986 by and between:

The MINISTRY OF HUMAN SETTLEMENTS, with principal office at Agustin I Building, Emerald Avenue, Pasig, Metro Manila, duly represented by its Deputy Executive Secretary HERMINIO S. AQUINO hereinafter referred to as the Presidential Task Force for PEACE;

- and -

The MINISTRY OF EDUCATION, CULTURE AND SPORTS, with principal office at Palacio del Gobernador, Intramuros, Manila duly represented by its Deputy Minister VICTOR M. ORDONEZ hereinafter referred to as the MECS.

WITNESSETH:

WHEREAS, the ratification of the Constitution signifies the beginning of the institutionalization of the democratic living of the Filipino citizenry as a people and as a nation;

WHEREAS, the impact and effects of the ratification of the Constitution will be centered on the future of the youth;

WHEREAS, the youth being the future leaders and participants of the country's labor force, must assume and demonstrate an active role in ensuring that the Constitution is properly disseminated and internalized by the entire populace; and

WHEREAS, the Ministry of Human Settlements (MHS) has conceived of the People's Educational Assistants for Community Enlightenment (PEACE) Program, which shall provide for meaningful and extensive mobilization of the youth in the coming constitutional exercise.

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree to implement the PEACE Program with the terms and conditions stipulated hereunder:

I. The Presidential Task Force for PEACE (PTFS) shall be responsible for the following:

1. The organization, training and mobilization of PEACE Officers and Volunteers for the Program;
2. The planning and implementation of programs, activities and special events for the PEACE in coordination with the PEACE Officers; and
3. The provision of logistical requirements and all other support services in relation to the conduct of information and education drive on the Constitution.

II. The Ministry of Education, Culture and Sports (MECS) shall be responsible for the following:

1. The issuance of a directive to the MECS Regional and Provincial Offices regarding the Ministry's participation in the PEACE Program;
2. The issuance of a circular to University/College Administrators introducing the PEACE Program and enjoining the students to involve and actively participate in all PEACE undertakings;
3. The granting of clearance to PEACE Officers/Volunteers to undertake in-campus, off-campus and community level PEACE Program Activities, provided it does not interfere with their program of studies; and
4. The proper recognition of PEACE activities as part of the requirements of some of the school's extra-curricular programs.

IN WITNESS WHEREOF, the parties through their duly authorized representatives have herunto set their hands this _____ day of _____ 1984 at Pasig, Metro Manila, Philippines.
