MECS INTEGRATED SCHOLARSHIP PROGRAM FOR SY 1987-1988

To: Bureau Directors
Regional Directors
Chief of Service and Heads of Units/Centers
Schools Superintendents
Presidents, State Colleges and Universities
Heads of Private Schools, Colleges and Universities
Vocational School Superintendents/Administrators

1. The Minister of Education, Culture and Sports hereby announces the Integrated Scholarship Program for 1987-1988.

2. Short-term courses will be offered on the elementary and secondary levels. Each region is allotted two slots for each short-term course. It is understood in this regard that all nomination papers for short-term courses must be approved by the regional office and received by the MECS Scholarship Committee two (2) months before the start of each course.

3. The flagship approach will be utilized in conducting the short-term courses. This means that short-term courses will be offered by institutions with expertise on the subject area. Hence, the following institutions which have manifested expertise in specific areas may be tapped as follows:

For Luzon:

De La Salle University	- Guidance
Philippine Normal College	- Sibika at Kultura
University of the Philippines	- Home Economics and Livelihood Education

Institute for Science and Mathematics Education	- Science/Math
Maryknoll College	- Special Education


For Visayas:

4. For the masteral or doctoral programs only one slot for each of the thirteen (13) regions shall be allowed. The regions shall undertake a screening process at their level and recommend only the best qualified nominee for this program.

GENERAL CRITERIA FOR SELECTING NOMINEES FOR A SCHOLARSHIP PROGRAM

1. Educational Qualifications

- a. Nominees for any maternal program must be bachelor's degree holders.
- b. Nominees for short-term courses must be bachelor's degree or maternal degree holders. They must have potentials for assuming leadership roles in their respective divisions/stations.

2. Experience and Training

- a. Nominees must actually be in the service and of permanent status.
- b. Nominees must have at least 3 years of very satisfactory teaching experience.
- c. Nominees must have experience in extra-curricular activities showing their leadership potential.

3. Nominees must be in good health.

4. Nominees must be of good moral character.

5. Nominees must not be more than 40 years old; those in the administrative and supervisory position, not more than 50 years old.

6. A women nominee shall not be pregnant during the stipulated period of scholarship. Youngest child must be not less than two years old.

7. Nominee should not have any pending administrative/criminal case.

8. Nominee must be prepared to advance expenses for board and lodging and book allowance if case funds for stipend are not released on time.

9. Obligation of the Grantee

The Nominee shall find himself to the terms and conditions stipulated in the scholarship contract. (Please see Inclosure No. 3).

10. Nominee should not have been a recipient of any MECS scholarship or training grant within the last five years before his nomination.

MEMORANDUM OF AGREEMENT
(Scholarship Contract)

and the _____, represented by _____, in consideration of the authority for me to avail myself of _____, in consideration of the authority for official time with or without pay, do hereby agree to the following terms and conditions:

1. That I will specialize in the _____ (school) for a period of _____ which will be the duration of the scholarship.
2. That I shall maintain at least the minimum standards of the program and that failure on my part to do so would be sufficient ground for my disqualification for the event of which I shall return whatever amount has been paid by the government in favor of my scholarship;
3. That I shall conduct myself in such manner as not to bring disgrace or dishonor to myself and/or my office/agency;
4. That I shall submit to the head of office and to the Ministry of Education, Culture and Sports through the MECS Integrated Scholarship Committee at the end of each quarter, term or semester, my official school transcript/grades, certification of performance or their equivalent, report of projects and term papers; & copy of my thesis and/or seminar paper;
5. That I shall immediately report to my office/station and assume my functions upon the completion or termination of my scholarship, fellowship or training grant;
6. That I shall conduct seminars/workshops upon request to my station;
7. That I shall serve my office/institution for at least three (3) years if my scholarship, fellowship, training or study grant is for a period of one year or less, and for another three years or a fraction thereof not less than two (2) months after one year;
8. That I shall refund in full to my office such sums of money as may have been defrayed by the Philippine government and/or myself for my transportation, allowances, salary and other expenses incident to my scholarship, fellowship, or training or study grant, for failing to comply with any of the foregoing conditions through my fault or willful neglect, resignation, voluntary retirement, or other causes within my control;
9. That I shall live up to the terms and conditions of this grant.
