1987 NATIONAL MUSIC COMPETITIONS FOR YOUNG  
ARTISTS (NAMCYA) AND MUSIC WORKSHOPS

To: Bureau Directors  
Regional Directors  
Schools Superintendents  
Presidents, State Colleges and Universities  
Heads of Private Schools, Colleges and Universities  
Vocational School Superintendents/Administrators

1. The Cultural Center of the Philippines (CCP), announces the National Music Competitions for Young Artists (NAMCYA) program for 1987.
2. The objectives of these competition-workshops are the cultivation of high quality music and the promotion and preservation of Philippine music. The competitions also aim to discover and develop musically talented school children.
3. The NAMCYA competitions will be in two phases: Phase A - this will be the regional music competitions to be held in the month of October in the following categories: (a) Children's Choir (elementary); (b) Youth Choir (secondary); (c) College Choir (tertiary); (d) Adult choir; (e) Piano; (f) Solo Instruments; (g) Family Ensemble; (h) Strings; (i) Solo Voice; and (j) Chamber of Music Ensemble. Only regional first prize winners shall be eligible to join Phase B. Phase B - Final national music competitions for regional first prize winners and other participants will be held at the Cultural Center of the Philippines during the National Music Week, November 20-27, 1987.
4. Expenses incurred by participants on the elementary and secondary levels incident to these competitions may be charged against local funds, subject to availability of funds and the usual accounting and auditing procedures.
5. Music teachers who are assigned to train and rehearse choral groups or individual participants in the regional competitions and national competitions will be given service credits and/or honorarium, subject to availability of local funds and the usual accounting and auditing procedures.
6. Students in the secondary and tertiary levels in both public and private schools who are directly participating in the NAMCYA competitions may be given credits which shall be 20% of the grade for the Music course during the period of participation. Elementary school children may be given credits or any other appropriate incentives by their school principal.
7. Regional directors assisted by their regional and division supervisors as coordinators, are hereby designated heads of the NAMCYA regional committee to oversee the contests in their respective areas.







The regional committee may request the governor of the province to be the chairman of the committee. Mrs. Gene Morales, Educational Researcher, Bureau of Secondary Education of the Ministry of Education, Culture and Sports, shall be designated as National Coordinator.

8. In support of the NAMCYA competitions, the 1987 National Music Seminar-Workshop for private and public school teachers under the joint sponsorship of the National Executive Committee of the NAMCYA, the CCP and the Ministry of Education, Culture and Sports will be held at the Cultural Center of the Philippines on April 20-26. Music teachers, music supervisors and trainers are expected to attend. Music teachers with nine units of Music earned in the undergraduate course and/or teachers who are presently active choral conductors are qualified to attend the seminar.

9. The workshop subjects shall be conducting techniques, vocal techniques, choral reading and choras. The amount of P450.00 will be charged as seminar fee.
