SUMMER WORKSHOP FOR LANGUAGE SUPERVISORS ON COMMUNICATIVE LANGUAGE TEACHING
FOR INTERMEDIATE AND ADVANCED STUDENTS OF ENGLISH AS A SECOND LANGUAGE

1. The Linguistic Society of the Philippines, in cooperation with the Philippine Normal College-Ateneo University-De La Salle University Consortium, the United States Information Service, the British Council, and with the sponsorship of the Fund for Assistance to Private Education, will conduct a workshop on communicative language teaching for intermediate and advanced students of English as a second language on April 20-May 15, at the De La Salle University, Taft Avenue, Manila.
2. Chief objectives of the workshop are: (a) to re-orient the approach and practices of English language supervisors and teachers in the Department of Education, Culture and Sports towards a communications approach to English language teaching; (b) to suggest and provide occasions for practice of feasible techniques and methods adapting current materials for communicative use; (c) to provide occasions for materials production demonstrating techniques and methods of communicative use especially in teaching the oral phase of the language.
3. Participants will be (a) English language supervisors (Department of Education, Culture and Sports) (one from each region); (b) chairpersons of English departments (especially those with graduate programs) of selected private universities (one from each region); and (c) Metro Manila English language supervisors/teachers (at their own expense or at the expense of their respective schools).
4. The transportation expenses of participants (by boat for those outside of Luzon) under 3a and 3b will be paid by the FAPE grant to the Linguistic Society of the Philippines. A partial allowance of one thousand pesos (P1,000) for board and lodging will be paid to each of the twenty-six participants in 3a and 3b (above). Since the P1,000 will not be enough for board and lodging in Manila, it is requested that supplementary funds be provided by the region from local funds, which is hereby authorized, subject to availability thereof and the usual accounting and auditing procedures.
5. Bro. Andrew Gonzalez, FCS, Executive Secretary of the Linguistic Society of the Philippines, and President, De La Salle University, is authorized to directly communicate with Regional Directors of the Department of Education, Culture and Sports regarding this workshop.
