WORKSHOP ON THE REVISION OF MINIMUM STANDARDS FOR PROGRAMS
IN AGRICULTURE AND ALLIED SCIENCES, FORESTRY AND FISHERIES

To: Bureau Directors
Regional Directors
Presidents, State Colleges and Universities
Heads of Private Schools, Colleges and Universities
Vocational School Superintendents/Administrators

1. To review, revise and improve the minimum standards for Bachelor of Science in Forestry/Forest Ranger, Bachelor of Science in Agriculture and allied sciences/Bachelor of Agricultural Technology/Associate in Agriculture and Bachelor of Science in Fisheries/Diploma in Fisheries Technology programs in line with the changing trends, needs and development of Agriculture, Forestry and Fisheries sectors to upgrade the effectiveness and efficiency of program offerings in the different educational institutions in the country, the Technical Panel for Agricultural Education (TPAE) will hold a workshop on the revision of Minimum Standards for programs in Agriculture and Allied Sciences, Forestry and Fisheries from April 21 to 25, 1987 at the Development Academy of the Philippines, Tagaytay City.

2. Participants to the workshop will be by invitation from TPAE which include:

- a. selected representatives from employers and successful entrepreneurs/farmers/fishermen/foresters.
- b. selected representatives from schools offering forestry, agriculture and allied sciences and fisheries programs and from professional organizations.
- c. selected representatives from DECS Bureau of Higher Education and DECS Regional Higher Education Divisions.
- d. TPAE members, concerned TPAE Committee members and Secretariat staff.

3. In case of unavoidable changes in the schedule, TPAE is authorized to determine the dates and place of workshop and to communicate the same to participants concerned.

4. Food and accommodation and workshop materials will be provided by TPAE. For invited participants coming from state colleges and universities and DECS supervised tertiary and second institutions, transportation and other expenses incidental to attendance in the workshop are chargeable against the funds of the office or school concerned, subject to the usual accounting and auditing regulations. The participants from the private institutions may have their own arrangement with their respective institutions. However, traveling and other expenses of invited persons will be shouldered by TPAE.
