NATIONAL CONSULTATIVE CONFERENCE AND WORKSHOP  
OF NFE IMPLEMENTERS

To: Bureau Directors  
Regional Directors  
Schools Superintendents

1. To achieve better perspective and efficiency in the implementation of NFE programs/projects and activities, the Bureau of Nonformal Education (BNE) will hold a 3-day consultative conference and workshop among NFE field personnel from the different regions/divisions of the country at Teachers Camp, Baguio City, on July 28-30. Inclosed is the tentative program of activities.

2. It is expected that at the end of the three-day gathering, the participants shall be able to:

- a. assess/review NFE programs/projects and activities undertaken in their respective regions/divisions;
- b. discuss problems, issues, strategies and other positive alternatives towards improving the NFE programs/projects and activities;
- c. identify pressing problems and possible solutions that will best meet the present needs of the clientele as well as the implementors;
- d. prepare a documentation of successful on-going BNE-assisted projects (Case Study); and
- e. formulate policies and guidelines for strengthening the implementation of NFE programs/projects and activities.

3. It is requested that each participant take along with him/her a copy of the action program of the region/division and the status report of their respective NFE programs.

4. Participants to this consultative meeting/workshop are as follows:

- 13 regional NFE supervisors  
(Ad Hoc Chairmen)
- 128 division NFE supervisors
- 39 BNE staff/support personnel
- 160 - Total

5. Travel expenses of participants from the official station to Teachers Camp and return shall be charged against local funds, subject to the usual accounting and auditing regulations. Board and lodging shall be provided by the Bureau.
