

CONVENTION OF PRESCHOOL EDUCATORS IN THE PHILIPPINES

To: Bureau Directors  
Regional Directors  
School Superintendents  
Presidents, State Colleges and Universities  
Heads of Private Schools, Colleges and Universities

1. The Coordinating Council for Early Childhood Education in the Philippines (COCEP), recently organized by DECS, is announcing its first convention to be held at the UP Alumni Center, Diliman, Quezon City on November 26-27, 1987.
2. The theme of the convention is "Working Together Towards a Relevant Preschool Education". The objectives of the convention are:
  - a. to get acquainted with the associations involved in preschool education;
  - b. to gain more knowledge on the Filipino child to make preschool education relevant to society;
  - c. to gain more information on the philosophies and new trends in preschool education;
  - d. to acquire new knowledge and skills in various subject areas in preschool education; and
  - e. to come up with resolutions on preschool education.
3. Participants to this convention are administrators, operators and educators who represent the different types of preschools from:
  - a. public schools
  - b. private schools
    - sectarian (with complete elementary school)
    - non-sectarian (with complete elementary school)
    - nursery/kindergarten schools (no elementary school)
    - church affiliated nursery/kindergarten schools







c. day care centers

- Department of Social Welfare and Development (DSWD) day care centers
- Rural Improvement Club (RIC) day care centers
- National Federation of Women's Clubs (NFWC) day care centers

d. state colleges and universities' laboratory schools

e. schools that do not fall under any of the above categories

A maximum of fifteen (15) participants from each region representing the above categories are invited to attend the convention.

4. A registration fee of five hundred pesos (P500.00) shall be charged each participant to cover expenses for lunch, snacks and handouts. Travel and other allowable expenses incurred by participants from government agencies may be charged against local funds, subject to the usual accounting and auditing regulations. Participants from private institutions may have their own arrangements with their respective schools.

5. For a more significant and responsive preschool education in the Philippines, it is desired that this Memorandum be immediately and widely disseminated to all schools concerned.
