FORMS FOR OPTIONAL RELIGIOUS INSTRUCTION
(Addendum to DECS ORDER No. 30, s. 1987)

To: Regional Directors
Schools Superintendents
Presidents, State Colleges and Universities

1. The Constitution provides for religious instruction of students in public elementary and high schools, at the option expressed in writing by the parents or guardian.

2. No student or pupil should, therefore, be allowed/permited to attend religious instruction classes without the written request or permission of his parents or guardian.

4. Principals are enjoined to strictly adhere to the above-mentioned requirements vis-a-vis religious instruction in public schools.
