Nov. 18, 1987 ..... Last Day of Appointment  
of Board of Inspectors

Nov. 19 to Feb. 17, 1988 ... Firearm Ban  
Ban on Partisan Political  
Activities by Public  
Officers and Employees

Nov. 28, 1987 ..... Special Registration Day

Dec. 4 to Jan. 19, 1988 ... Ban on Appointments or  
Hiring of New Employees,  
Creation of New Positions,  
Promotion or Giving  
Salary Increases

Jan. 8, 1988 ..... Revision Day

Feb. 17, 1987 ..... End of Election Period

b. The Chairman and Members of the Board of Election Inspectors shall each receive per diem at the rate of One Hundred Pesos (P100.00), for actual service on registration and revision days and Two Hundred Pesos (P200.00) on Election Day. Support







- personnel of the Department of Education, Culture and Sports shall receive a per diem of Fifty Pesos (P50.00) during Election Day.
- c. Supervisors, principals, and other administrators of the Department of Education, Culture and Sports, who are designated and appointed by the Commission, and who actually report for supervisory assignment during registration, revision and election days shall be entitled to a per diem of One Hundred Pesos (P100.00).
  - d. Payment of per diems shall be made within Seventy-Two (72) hours after registration, revision or election day through the Division and City Schools Superintendents who shall immediately effect payment to the teachers.
  - e. The Chairmen and other two members of the Board of Election Inspectors shall be insured with the Government Service Insurance System (GSIS) at Fifty Thousand Pesos (P50,000.00) each (life and accident) under such terms and conditions as may be agreed upon by the Chairman of the Commission of Elections, the Secretary of the Budget and Management and the Secretary of Education, Culture and Sports.
