1. The Coca-Cola Foundation Philippines, Inc. in cooperation with the Department of Education, Culture and Sports is launching a nationwide art contest for all public elementary school pupils from Grades I to VI. This contest will run from May 13 to September 12.

2. Entries must depict the theme "Ang Galing ng Pinoy!" in commemoration of the forthcoming Philippine Centennial.

3. Participants may use crayons, craypas, watercolor, oil paints, pentel pen, found objects, indigenous materials or any combination of the aforementioned media done on any flat 18"x 20" surface.

4. Entry forms will be distributed to all public elementary schools by Coca-Cola Plants throughout the country. All entries must be submitted on or before the close of office hours (5:30 p.m.) on September 12 to:

Thirteen national finalists shall be chosen and will be awarded 4-year non-exclusive college educational scholarships, cash prizes, plaques of achievement, all expenses paid two-night and three-day stay in Manila and other prizes from sponsors. There will also be awards for schools of 1st, 2nd and 3rd prize winners as well as teachers of the 13 national finalists.

6. Other details regarding the contest rules and regulations are provided in the inclosure.

7. Immediate and wide dissemination of this Memorandum to all concerned is desired.

Contest Rules & Regulations

1. The contest is open to **ALL PUBLIC ELEMENTARY SCHOOL STUDENTS from GRADES 1 TO 6 NATIONWIDE.**

Contest begins May 13, 1997.

All entries must be submitted on or before close of business hours (5:30 p.m.) on Friday, September 12, 1997 to:

2. CONTESTANTS MUST ACCOMPLISH AN OFFICIAL ENTRY FORM signed by the school principal and the child's art teacher to certify that the participant is a bona fide student in the school. Parents must also sign on the blank provided in the entry form to certify consent and approval for all phases of the art contest. This FORM MUST BE TAPE ONTO THE BACK OF THE ENTRY.

All children and relatives of employees of Coca-Cola Foundation Philippines, Inc., Coca-Cola Bottlers Philippines, Inc., Coca-Cola Far East Ltd., and The Coca-Cola Export Corporation upto the second degree of consanguinity are disqualified from joining.

3. Entries must depict the theme: **Ang Galing ng Pinoy!**
 4. Entries must be done on any flat 18" x 20" surface (cartolina, illustration board white board). Participants may use crayons, craypas, watercolor, oil paints, pentel pen, found objets, indigenous materials or any combination of the above media.
- Entries must be protected by a clear plastic cover.
5. Only one entry per participant.
 6. The participant must waive in favor of the Foundation all their property and artistic rights over the entries submitted. Upon submission, the entries shall be the property of the Foundation.

7. Thirteen national finalists shall be chosen. National finalists shall be notified through their local Coca-Cola Plants or by telegram where there are no plants.
8. National finalists shall be required to recreate their entries to ensure that they are authors of the same.
9. National finalists will be required to claim their prizes in November 1997. All expenses for travel and accommodations shall be borne and shouldered by the Foundation.
