PRODUCTION OF PEACE EDUCATION MODULE FOR SECONDARY LEVEL

To: Bureau Directors
Regional Directors
Schools Superintendents

1. As part of the continuing peace process and following the production of peace education module for elementary level is the production of a module for the secondary level. This project is one of the special programs of the DECS and the Office of the Presidential Adviser on Peace Process (OPAPP) and is being coordinated by the Staff Development Division, HRDS and the National Educators Academy of the Philippines. The activities for the project and corresponding dates and venues are as follows:

I. Writing-Workshop - April 14-21, Ciudad Christhia,
54 Balante, Ampid, San Mateo, Rizal

II. Orientation on the Field-Testing of the Module

Batch I - May 28-29, Applied Nutrition Center
(For Regions VI, IX and XI)

Batch II - June 3-4, NEAP, Baguio City
(For Regions I, IV and V)

III. Actual Field-Testing - July-November
Selected schools

IV. Final Revision - December 15-19
(Venue to be announced later)

V. Production and Distribution - January-February 1998

2. The Peace Education project is aimed at:

a. promoting peace among teachers and school children;

b. equipping school children with peace-making and peace-building skills; and

c. producing instructional materials highlighting peace concepts with reference to the desired learning competencies.

3. List of writers and project staff for the writing-workshop is inclosed. The orientation and field-testing will be participated in by secondary classroom teachers, principals and regional/division supervisors for social studies or values education coming from the divisions mentioned in the inclosure. Said divisions are to select 3 schools (2 public and 1 private) which will serve as field-testing schools. The teachers and principals must come from these schools. Each school shall have two teachers who will demonstrate lessons for year I to IV during the field-testing. The regional and division supervisors shall coordinate the participation of schools and other activities related to the field-testing.

4. Travel expenses and per diem (before and after the duration) are chargeable against local funds. Board and lodging of all participants and staff, travel expenses and per diem of NEAP-SDD staff in all activities including field-testing, honoraria of writers, facilitators, monitors and project staff in all activities; production cost and other incidental expenses for the project are chargeable against Function A.1.5.5.6. (HRDS Special Programs), subject to the usual accounting and auditing rules and regulations.

5. Immediate and wide dissemination of this Memorandum is desired.
