
**CURRICULUM AND INSTRUCTIONAL MATERIALS REVISION**  
**WORKSHOP FOR POPULATION EDUCATION**

To: Bureau Directors

1. In SY 1996-1997, the enriched curriculum and support instructional materials in population education were pilot-tested in seventeen (17) schools/institutions in sixteen (16) regions by selected tryout personnel of DECS/CHED/TESDA. Consequently, from April 7-14, a Curriculum Revision Workshop to finalize the draft enriched population education curriculum and support instructional materials will be conducted by the Population Education Program, Department of Education, Culture and Sports (PEP-DECS) at the Anne Raquel's Resort, Olongapo City.
2. The participants will be composed of a) 24 curriculum writers from elementary, secondary, nonformal and tertiary/technical-vocational education who helped develop and pilot said curriculum and materials, b) 6 artists/encoders, and c) PEP staff/secretariat (see Enclosure 1).
3. Workshop participants are requested to proceed on their own to the workshop site on April 7 and check in at the conference site by 12:00 noon. Reimbursement of their travel expenses will be given upon arrival at the conference site.
4. Transportation by land/board and lodging of all participants in this workshop will be charged to PEP project funds subject to the usual accounting and auditing rules and regulations.
5. Immediate dissemination of this Memorandum to all concerned is desired.
