ORIENTATION SEMINAR FOR TEACHERS AND FIELD-TESTING  
OF GRAFT AND CORRUPTION PREVENTION MODULES

To: Bureau Directors  
Regional Directors  
Schools Superintendents

1. The Staff Development Division, HRDS and the National Educators Academy of the Philippines (NEAP), will conduct a two-day live-in orientation seminar among elementary and secondary school teachers on the use of the graft and corruption prevention modules. This will be in 3 batches, as follows:

Date	Venue	Regions
April 29-30	NEAP, Teachers Camp	III and IV
May 7-8	Davao	XI and XII
May 27-28	ECOTECH, Cebu	VI and VII

Field-testing of modules in divisions mentioned in the inclosure will be done starting July 1997. Schedules of field-testing will be discussed during the orientation seminars.

2. Participants to the orientation seminars are the following:

- \* 3 teachers and the principal from each participating elementary school
- \* 2 teachers and the principal from each participating secondary school
- \* 1 division supervisor from selected divisions
- \* 1 regional supervisor  
(to coordinate the participation of two private schools, 1 for elementary and 1 for secondary in the region during the orientation and field testing)

3. The monitors/evaluators are the module writers from DECS and SDD/NEAP trainors. Participating divisions are to select four public schools for the field-testing (2 elementary and 2 secondary).

4. Travel expenses, airfares, per diem and other allowable expenses of participants are chargeable against local funds while board and lodging of participants, writers/monitors and staff

including all travel expenses and per diem of DECS writers/monitors and staff for orientation and field-testing are chargeable against A.1.5.5.6 (Special Programs). All expenses are subject to the usual accounting and auditing rules and regulations.

5. Immediate dissemination of this Memorandum is desired.
