REGIONAL CONSULTATION ON THE NATIONAL TEACHERS' AND EMPLOYEES' COOPERATIVE BANK

- 1. Pursuant to DECS Memorandum No. 68, s. 1997 entitled "Establishment of the National Teachers and Employees Cooperative Bank, the Philippine Federation of Teachers and Employees Cooperatives (PFTEC), in coordination with the Department of Education, Culture and Sports, and the Joint Development Ventures Foundation, Inc., shall conduct a regional consultation throughout the country to disseminate information on the establishment of the cooperative bank. The consultation shall also serve as a forum on teachers cooperatives.
- 2. The regional consultation aims to facilitate the establishment of the cooperative bank through an information dissemination campaign. Specifically, it aims to:
 - a. Generate awareness on the benefits to be derived from cooperatives;
 - b. Provide necessary knowledge and skills regarding the effective management of cooperatives; and
 - c. Provide a better understanding of cooperatives.

- Participants to the regional consultation are schools directors, schools superintendents, assistant superintendents, division coordinators of cooperatives, chairman of the board of directors, general manager, secretary and treasurer of existing DECS teachers and employees cooperatives, and two (2) district supervisors and two (2) school principals from each division. Participants are requested to confirm their attendance and make reservations one week before the scheduled regional consultation with the regional/division coordinator on cooperatives, the regional PFTEC Board member, the office of the PFTEC Board Chairman, Attn. Ms. Celedonia Notarte, tel. no. 035-225-0667; or with the Employees Welfare and Benefits Division, DECS Central Office, tel. no. 633-7229. Priority shall be given to pre-registered participants.
- 5. A registration fee of one thousand seven hundred pesos (\$1,700.00) shall be charged each participant to cover the cost of board and lodging, food, snacks, and handouts.
- 6. Travel expenses, registration fees and other expenses incident to the attendance of officials and personnel concerned shall be charged against their respective local funds, subject to the usual accounting and auditing rules and regulations.
