DIWANG FILIPINO SEMINAR-WORKSHOP

To: Bureau Directors
Regional Directors
Schools Superintendents
Heads of Private Secondary Schools
Vocational School Superintendents Administrators

1. Pursuant to Proclamation No. 946, declaring 1997 as "Taon ng Diwang Filipino", the Filipino Spirit Committee of the National Centennial Commission (NCC), chaired by the Secretary of the Department of Education, Culture and Sports will hold a Seminar-Workshop on May 5-7 at the Las Brisas, Antipolo, Rizal.
2. The seminar-workshop aims to orient participants on the Program of the Diwang Filipino, its components, objectives, implementing agencies, projects, activities, and significance relative to the Philippine Vision for 2000 and beyond, in order to enhance understanding of school children and the general public on historical and centennial events.
3. The participants shall be those who attended the Centennial Workshops (DECS Memorandum No. 101, s. 1996) held in Luzon (Imus Sports Complex, April 10-13, 1996), Visayas (Tacloban, Leyte and Mindoro, April 25-28) and Mindanao (Zamboanga del Norte, May 8-11), regional and divisional cultural coordinators/and master teachers of English, Filipino, Social Studies, Values and Physical Education, Health and Music (FEHM).
4. The expected outputs of the participants of this workshop include: (1) documented regional reports on the 1996 Centennial activities; (2) Management Action Plans for the 1997-1998 (centennial projects and activities) as well as sample teaching modules of 1997 historical events in the different subject areas.
5. There shall be no registration fee. Board and lodging shall be co-sponsored by the Filipino Spirit Committee and the Office for Culture and Arts. In addition, NCC published books and other instructional materials (print and non-print) shall be given free. Traveling expenses, however, of public school participants shall be charged to local funds subject to the usual accounting and auditing rules and regulations. Private school participants shall make the necessary arrangements with their own institutions. Each region shall be allocated eight (8) from the private schools and six (6) from the public schools.

6. Immediate dissemination of this Memorandum to all concerned is desired.
