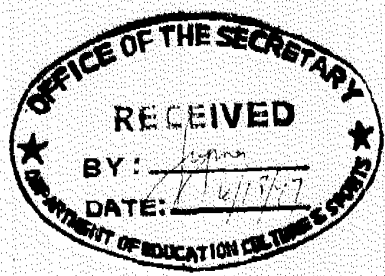

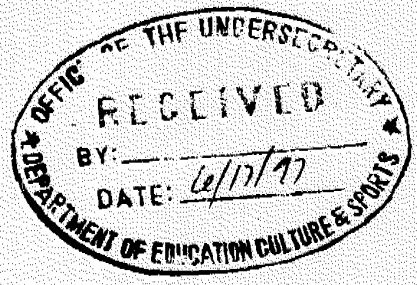


Gentleman:
