SUBJECT : **DEFINING THE LINE OF AUTHORITY BETWEEN PCANMAL
AND CONCERNED PARTIES RELATIVE TO PLANS AND
PROGRAMS FOR THE REHABILITATION AND DEVELOPMENT
OF THE NATIONAL MUSEUM, NATIONAL ARCHIVES AND
NATIONAL LIBRARY**

D A T E : 11 June 1997

Pursuant to Section 2, paragraphs (a) and (b) of Administrative Order Number 315 (s. 1997), the Presidential Committee to Assist the National Museum, National Archives and National Library (PCANMAL) shall undertake the following:

1. Formulate a comprehensive strategy or plan for the rehabilitation, development and operation of the National Museum, National Archives and National Library consistent with their purposes, and which will harness the collective strength of the government and the private sector, and submit the same to the President, for approval; and
2. Implement, coordinate and monitor fund-raising projects, programs and activities, pursuant to the said strategy or plan, to finance the rehabilitation and development of the National Museum, National Archives and National Library.

Relative thereto, you are hereby instructed to comply with the following guidelines in the pursuit of the foregoing tasks:

1. All Strategy Plans and Programs for the Rehabilitation/Upgrading of the National Museum, National Archives and National Library shall be reviewed by the PCANMAL and endorsed to the President for approval.
2. Once approved by the President, no deviations/changes thereon shall be made on said strategic plans/programs without the approval of the PCANMAL. Specific plans/programs proposed by the National

Museum, National Archives and National Library that may impinge on the approved Strategy Plans and Programs shall be submitted to the PCANMAL for review and approval.

3. Utilization of funds (from government or private sources) earmarked for the rehabilitation/upgrading of the National Museum, National Archives and National Library shall likewise require the review and approval of PCANMAL. In this regard, the PCANMAL shall prepare cash flow plans to implement the Strategy Plans/Programs for these structures.
4. The PCANMAL shall formulate mechanisms to determine which components of the Plan shall be provided government funding consistent with existing government budgeting, accounting and auditing rules and procedures and specific mandates of the concerned agencies.

Further, you are hereby directed to pursue collaborative efforts and undertake continuing consultations to ensure that implementation targets are met on schedule.

The Chairman of PCANMAL shall submit a report on the status of implementation of the Strategy Plan for the Proposed Rehabilitation of the Finance Building which I approved on 27 February 1997, through the Executive Secretary copy furnished the Head, Presidential Management Staff, not later than 15 July 1997 and every month thereafter.
