FIRST NATIONAL CONFERENCE OF THE PHILIPPINE
ASSOCIATION OF NONFORMAL EDUCATORS

To: Bureau Directors
Regional Directors
Schools Superintendents

1. In response to the Government's thrust to eradicate illiteracy by the year 2000 and in support of its policy on poverty alleviation through people empowerment, the Philippine Association of Nonformal Educators, Inc. (PANFEI) in coordination with the Bureau of Nonformal Education (BNFE), DECS, is sponsoring the First National Conference of the Philippine Association of Nonformal Educators at the Imus Sports Center, E. Aguinaldo Highway, Imus, Cavite on October 13-14, 1997.
2. With the theme "Nonformal Education in the Third Millennium: A Shared Commitment", the objectives of the conference are to:
 - a. discuss the different thrusts of the Nonformal Education;
 - b. recognize the role of NFE in promoting responsive NFE programs;
 - c. establish collaborative relations among NFE implementors and stakeholders;
 - d. ratify the Constitution and By-Laws of the Philippine Association of Nonformal Educators, Inc.; and
 - e. elect officers of the association.


3. Participants shall come from the BNFE regional and division offices. All regional directors, assistant regional directors, NFED chiefs and assistant chiefs, NFE regional supervisors II, schools superintendents, assistant schools superintendents in-charge of NFE, division NFE supervisors/coordinators and presidents/chairpersons of the Division Association of NFE Implementors are enjoined to attend the conference.

4. The chief of the Nonformal Education Division in each region will submit the list of participants to the Staff Development Division, BNFE, DECS on or before August 31.

5. Travelling expenses including a registration fee of two thousand five hundred pesos (P2,500.00) per participant for board and lodging, kits and handouts shall be charged against local funds subject to the usual accounting and auditing rules and regulations. Check-in time of participants at the venue is in the afternoon of October 12.

6. The tentative schedule of activities is inclosed.
