REITERATING THE SEARCH FOR THE HUWARANG PAMILYANG PILIPINO

To: Regional Directors


- 1. This Memorandum reiterates the contents of DECS Memorandum No. 185, s. 1997 entitled Search for the 1997 Huwarang Pamilyang Pilipino.
- 2. The Subcommittee on the Search for Huwarang Pamilyang Pilipino is chaired by the Secretary of Education, Culture and Sports. The DECS Regional Directors in their capacity as Chairmen of the Search at the regional level shall nominate the best and qualified Huwarang Pamilyang Pilipino from their respective regions.
- 3. All Regional Directors should submit their regional winners' names including the documents needed as specified in the guidelines on both the <u>Family</u> and <u>Solo Parent</u> categories on or before September 1.
- 4. Guideline No. 2 on Eligibility whose content is the same as in the nomination form shall read as follows:
 - 2. A family whose members have no pending/have not been convicted of any administrative, criminal and/or civil cases.
