NATIONAL CONVENTION ON PRIVATE PRESCHOOL EDUCATION

To: Regional Directors

Private Preschool Principals and Administrators

- 1. The Coordinating Council of Preschool Education in the Philippines, Incorporated (CONCEP, Inc.) will hold its first national convention at the Robinsons Galleria Suites, Amorsolo Grand Ballroom on February 25, 1998.
- 2. The theme of the convention is "Total Quality Management of Resources For Philippine Preschools". Alternative modes will be discussed with special focus on the management of resources.
- 3. Participants will be preschool administrators, practitioners and teachers in the private schools and public school administrators and teachers who may be interested to join the convention.
- 4.
