REORIENTATION WORKSHOP FOR CORE TRAINERS OF THE REVITALIZED HOMEROOM GUIDANCE PROGRAM (RHGP) AND THE NATIONAL TRAINING OF DIVISION SUPERVISORS AS RHGP TRAINERS

To: Regional Directors
Schools Superintendents

- 1. In view of the Institutionalization of the Revitalized Homeroom Guidance Program (RHGP) in SY 1998-1999 as enunciated in DECS Order No. 67, s. 1997, the Bureau of Secondary Education (BSE) and the Philippine Center for Population and Development (PCPD) will conduct two workshops for RHGP trainers at the Junior Mess, Teachers Camp, Bagulo City. The first workshop is the Reorientation of Core Trainers on the RHGP which will be held from February 25 to March 7, 1998. The second workshop is the National Training of Division Supervisors as RHGP Trainers to be held from March 1 to 7, 1998.
- 2. The first workshop is intended to enhance the knowledge, skills and attitudes of 54 RHGP Core Trainers on the revised Resource Manual. The second workshop is almed at equipping 140 Division Supervisors in charge of Guidance and Values Education and 16 potential RHGP Core Trainers with knowledge, skills, and attitudes necessary for the effective training of School-Level Trainers.
- Participants who have classes assigned to them will be substituted by teachers within their respective departments.
- 4. Participants are expected to arrive at Teacher's Camp in time for dinner on February 25, 1998 for the first workshop and in time for dinner on March 1, 1998 for the second workshop.
- 5. Participants are advised to bring along materials relevant to the training.

- 6. Transportation of participants for the first workshop to and from Teachers Camp will be shouldered by PCPD while that for the second workshop shall be charged to local funds subject to the usual accounting and auditing rules and regulations. Board and lodging and other incidental expenses of participants for both workshops shall be charged to PCPD and BSE subject to the usual accounting and auditing rules and regulations.
