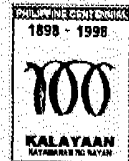

DECS MEMORANDUM

**1998 LICENSURE EXAMINATION FOR TEACHERS (LET)**  
(Elementary and Secondary)

To : Regional Directors  
Schools Division Superintendents

1. Pursuant to R.A. 7836, otherwise known as "The Professional Teachers Professionalization Act of 1994", the Professional Regulation Commission (PRC) and the Board for Professional Teachers (BPT), in coordination with the Department of Education, Culture and Sports (DECS), will administer the third Licensure Examination for Teachers (LET) for both elementary and secondary levels, in thirteen (13) Regional Filing/Examination Centers (RFEC) nationwide on August 1 and 2, 1998.
2. Applications may be filed at the PRC Main Office, PRC Regional Offices in Baguio, Legazpi, Cebu, Davao and Cagayan de Oro Cities for Regions 4 and NCR, 1/CAR, 5, 7, 10 and 11, respectively, from **March 2 to May 31, 1998** and at the DECS Regional Offices in Regions 2, 3, , 6, 8, 9 and 12 from **May 12 to May 31, 1998**.
3. Regional Directors through the Division Superintendents in Regions 2, 3, 6, 8, 9, 12 and NCR are enjoined to provide a room or space for the PRC Teams who will temporarily hold office and receive applications relative thereto; likewise, dormitories or home economics buildings shall be made available to house or accommodate the said teams during the application and examination periods.
4. All Regional Directors and Schools Division Superintendents are also enjoined to make available all public school buildings and facilities as venues of examination and to provide the requested and necessary number of school teachers and other DECS personnel to serve as Examination Supervisors and Room Watchers/Proctors.

5. School teachers and other personnel who will serve in the examination shall be given service credit units.
6. All DECS Regional Directors are further enjoined to designate an officer who shall assist the PRC Team in the examination activities.
7. Since the DECS will eventually be the agency which will benefit the most in this Licensure Examination, utmost cooperation to the PRC is being requested.
8. Immediate dissemination of this Memorandum is desired.
