- 1. The Philippine Guidance and Counseling Association, Inc. (formerly PGPA), will hold its 34<sup>th</sup> Annual Convention-Workshop on the theme "Facing the Challenges of the 21<sup>st</sup> Century: Counselors' Responsibility". The convention will be held on May 13, 1998 at the Garden Ballroom of Shangrila's EDSA Plaza, Ortigas, Mandaluyong City. The May 14-15, 1998 workshop will be held at the Balay Kalinao, Guerrero St., UP Diliman, Quezon City.
- The convention-workshop is designed to provide the participants:
  - a. opportunity to share knowledge and insights on the challenges which the counselors together with their clientele will encounter as the century unfolds;
  - b. skills in a cooperative/consultative networking among practicing counselors in the country;
  - c. competencies and creative skills in maximizing the development of the potentials of the Filipinos; and

Participants from private schools shall make their own financial arrangements with their respective institutions or sponsoring agencies/organizations. Participants from the public schools are encouraged to source out funds for their registration fees.
