NATIONAL TRAINING OF REGIONAL AND DIVISION TRAINERS IN P.E. FOR FIRST YEAR AND SECOND YEAR HIGH SCHOOL

To: Bureau Directors
Regional Directors
Schools Superintendents
All Others Concerned

- 1. The Bureau of Physical Education and School Sports (BPESS) through its Curriculum Development Division (CDD) and in collaboration and consultation with the Bureau of Secondary Education (BSE) will conduct a National Training of Regional and Division Trainers in P.E. for First Year and Second Year High School at Teachers Camp, Baguio City on May 13-19, 1998.
- 2. The objective of the training is to enchance the competencies of trainers in physical education to effectively train First Year and Second Year High School P.E. teachers in the implementation of the physical education and school sports curriculum/program at the secondary level.
- 3. Participants to this training will be the regional PESS and Secondary Division Chiefs or their representatives, one P.E. division Supervisor/Coordinator per school division and one PEHM head teacher/department head from each region. Ten (10) training specialists will be invited to augment the training staff of the CDD.
- 4. After the national training, the Regional PESS Division Supervisors together with the trained Division PE Supervisors, are expected to conduct a regional training program for additional division P.E. trainers. These additional division P.E. trainers will team up with the division PE trainers trained in Baguio City in conducting training program/s in PE for First Year and Second Year teachers in their respective divisions.
- 5. Travel expenses of regional and division participants shall be charged against local funds. Those of the DECS Central Office and BPESS staff and invited training/sports specialists, resource persons/consultants and medical personnel shall be charged against BPESS funds subject to the usual accounting and auditing rules and regulations. (See Enclosure) Board and lodging of all participants, training/sports specialists/ resource persons/consultants and BPESS management and support staff, and other expenses incidental to this activity shall be taken care of by the BPESS.

- 6. Registration of participants will be on Tuesday, May 12, 1998 beginning at 1:30 p.m. at the Quirino Hall, Teachers Camp, Baguio City. Food services will start with afternoon snacks on the same day.
